

WAIVER, RELEASE AND ASSUMPTION OF RISK

This is a legal document.

Read and understand this document before signing.

In consideration of being allowed to participate in the Promontory Point Clean-Up activity (the "Activity") being sponsored by Beta Chapter of Alpha Kappa Alpha Sorority ("AKA"), I and if I am not yet 21 years old, my parent(s) or legal guardian(s) (individually and collectively referred to below in the first person singular) agree to be bound by each of the following:

I agree that AKA is not responsible for enforcing policies to prevent the spread of COVID-19 or other communicable diseases. By proceeding to participate in this Activity, I acknowledge and voluntarily assume all risk of exposure to or infection with COVID-19 and/or other communicable diseases and that such exposure or infection may result in serious injury, illness and death.

I waive and release all claims for injuries, illness, damages or loss which I (or my minor child/ward) may sustain from my voluntary participation in the Activity (including any transportation services) in their entirety including any claims against AKA, its chapters, their respective officers, agents, volunteers, members and employees (hereinafter collectively referred to as "AKA Representatives").

Photo/Video Policy and Warning: Photos, live-streaming and video footage (collectively "Video Footage") may be taken of me participating in or attending the Activity. I understand that by participating in the Activity, I authorize AKA to use the Video Footage for non-commercial purposes including social media and AKA's website without additional prior notice or permission and without any compensation to me. All Video Footage is the property of AKA.

I agree that this Agreement is to be governed by Illinois law and expressly consent to jurisdiction in and venue in Cook County, Illinois. If any portion of the Agreement is held invalid, the remainder shall continue in full force and effect.
